You must declare your interest before the matter is discussed or as soon as the interest becomes apparent except when this arises because you (a) are a member or senior member of another public body, or (b) have been appointed to serve as the Council's representative on another body. In such circumstances you need only declare your interest if you intend to speak or do speak. 3. You should say you have a personal interest in item... and declare its nature. Having declared your interest, you are then entitled to remain in the meeting, and you can also vote at the end of the debate.
